COOKIE POLICY

1. Preamble

WORLD TABLE TENNIS wishes to inform you in a clear and transparent manner about the use of cookies when you consult the https://tickets.wttmontpellier.com website (hereinafter the "Site").

In order to enable Internet users to benefit from the services offered by the Site, such as consultation, optimisation of its use or personalisation according to the Internet user, the Site uses cookies. You may deactivate the cookies to which you have consented at any time, free of charge, using the deactivation options offered to you and described below.

2. Definitions

When you visit the Site, information relating to the browsing of your terminal (computer, tablet, smartphone, etc.) on the Site may be recorded in text files called "cookies", installed on your browser. Cookies are used to recognise your browser for the duration of the validity of the cookie concerned and to send certain information back to the Site (for example, a session identifier or the choice of language).

Only the sender of the cookie in question is likely to read or modify the information contained in it.

There are different types of cookies:

- session cookies which disappear as soon as you leave the Site;
- permanent cookies which remain on your terminal equipment until their lifetime expires or until you delete them using the functions of your browser.

You are informed that, during your visits to this Site, cookies may be installed on your terminal.

3. Purpose of the cookies used

Cookies are used by our Site for different purposes :

- to facilitate your navigation ;
- offer personalised content: our Site uses cookies to personalise the editorial content of our Site according to your use ;
- to compile statistics on visits and measure the audience for the Site.

Some cookies, which are not subject to your consent, are essential for using the Site. These are functional cookies used by WORLD TABLE TENNIS to :

- keep your session active ;
- save your choices about cookies ;
- save your choice of language ;
- remember the contents of a shopping cart ;

Other cookies, which are subject to your consent, are used to improve the performance of the Site, and allow the WORLD TABLE TENNIS to analyse and measure the number of visitors to the Site and to offer targeted advertising.

4. Cookies used by our site

The cookies used on the Site are the cookies deposited by WORLD TABLE TENNIS, detailed in the table below:

5. Consent

On your first visit to the Site, you will be given the opportunity to accept or decline the use of certain cookies.

You can also give your consent independently and specifically for each separate purpose via the "Cookie Settings" option.

When you accept the deposit of cookies, a consent cookie is set.

If you do not want cookies to be installed or read on your terminal equipment, an opt-out cookie will be placed on your equipment so that WORLD TABLE TENNIS can record the information that you have objected to the use of cookies for a period of 6 months.

If you delete this refusal cookie, it will no longer be possible to identify you as having refused the use of cookies.

The consent or refusal cookies must remain on your terminal equipment. You can change your choices at any time by clicking on "Cookie settings".

6. Cookie management

You can manage and modify the use of cookies at any time according to the possibilities listed below :

- directly on our Site, in the module provided for this purpose, by clicking on "Cookie settings" or
- from your browser, or
- from inter-professional opposition platforms.

Please note: your refusal to install a cookie is based on the deposit of a cookie. Consequently, if you deactivate all cookies on your terminal or if you change terminal, we will no longer know that you have chosen this option.

• Cookie management module

A module allows you to choose which cookies you wish to accept and which you wish to reject on this site.

At any time, by clicking on "Cookie settings" you can access the module and change your preferences..

Browser settings

You can configure your browser so that cookies are stored in your terminal or rejected, either systematically or according to their sender.

You can also regularly delete cookies from your terminal via your browser.

However, don't forget to configure all the browsers on your various terminals.

• Opposition platform

Several platforms of advertising professionals also offer you the possibility of refusing or accepting cookies used by their member companies. These centralised mechanisms do not block the display of advertisements, but only prevent the installation of cookies that allow advertisements to be tailored to your interests and behaviour.

For example, you can log on to the www.youronlinechoices.com website to prevent the installation of these cookies on your terminal. This site is proposed by digital advertising professionals grouped together within the European Digital Advertising Alliance (EDAA) and managed in France by the Interactive Advertising Bureau France.

You will be able to find out which companies are registered on this platform and which offer you the possibility of refusing or accepting the cookies they use to adapt, according to the data they collect, the advertisements likely to be displayed on your browser: <u>https://www.youronlinechoices.com/uk/your-ad-choices</u>.

This European platform is shared by hundreds of Internet advertising professionals and constitutes a centralised interface allowing you to express your refusal or acceptance of cookies as specified above.

7. Protection of personal data

In the context of the use of cookies as described above, the WORLD TABLE TENNIS is likely to process personal data about you, such as IP addresses, as the data controller.

The purposes of these cookies are detailed above in section 3 "Purpose of the cookies used".

The processing of your personal data collected from cookies subject to your consent is based on your consent. The processing of your data from cookies exempt from consent is based on the WORLD TABLE TENNIS's legitimate interest in ensuring the proper functioning of its site.

The data collected by the cookies used by the Site will be communicated to authorised personnel in the WORLD TABLE TENNIS's customer relations department and to its subcontractors.

Cookies are never kept longer than necessary to achieve the purpose of the cookie and, in any case, not longer than 13 months. The data collected from cookies is kept for a maximum of 25 months.

You can withdraw your consent at any time from the management module accessible on all pages of the Site or on "Cookie settings".

You have the right to access, rectify, delete and port your data, as well as the right to limit the processing.

You also have the right to object at any time, for reasons relating to your particular situation, to the processing of personal data whose legal basis is the FFR's legitimate interest.
